<u>Step 2</u>: Open an Account. This step is only necessary the first time you register, if you have completed this please proceed to step 6.

Step 6: Once you click Submit Form above, in ~30 seconds you are directed to the following page where you can initiate the specific case you would like to be processed. Each petition type is a short one page form that takes only a moment or two to complete. This gives ISS basic information as well as authorization to begin working on your petition. You will be contacted via email from accounting with an invoice and typically within 2-3 business days you will be contacted personally by your assigned case manager to continue your process. You may use the direct link <u>HERE</u> to visit this page for any subsequent petitions as steps 1-5 only need to be performed for your very first petition.

If you are not sure, please contact us at 1-800-437-7313, and we will be glad to discuss the specifics with you. **H-1B Visa Petition** Visa Extension "Specialty Occupation" to include dependent H-4. For any non-immigrant (e.g. H-1B or L-1) visa extension only if ISS completed the original or previous petition for this employee. L-1 Visa Petition Green Card Intra-company transfer. Both L-1A-Senior Executive and L-1B Employment-Based Permanent Resident Visa (e.g. EB-1,2,3). For "Specialized Knowledge." Family-Based Green Cards please select the Family Green Card. **All Other Visa Petitions Citizenship Petition** All other visa classifications not listed above. Naturalization application for current Green Card holders. H-2B Visa Petition Family Green Card Green Card based on a family relationship (e.g. spouse, minor child). Temporary Worker (duration less than one-year). ISS prepares Family-Based Permanent Resident Visa petitions only for existing employment-based clients.
